## Module Aims

The aim of the module is to examine the principles of microeconomic theory and to illustrate the application of theory to contemporary economic issues. Students will learn how to construct theoretical models from a varying set of assumptions. These models are applied to empirical situations and then related to contemporary debates and policy problems. The module provides the necessary foundation for further study of microeconomic principles and their application in Stages 2 and 3 of the undergraduate Economics degree.

# Learning, Teaching and Assessment Strategy

Lectures will outline and examine the key principles of microeconomics, supported with weekly seminars discussing key themes from the lectures of the preceding week. In the seminars, students will have the opportunity to apply microeconomic theory to economic, political, and social phenomena that occur in the real world. Additional materials will be provided for students on the Virtual Learning Environment.

Students? understanding on various issues covered in this module across the year will be examined through 2 closed-book exams. A 1.5-hour exam will take place at the end of the first semester, accounting for 35% of the total marks. Another 2.5-hour exam will take place at the end of the second semester, accounting for 65% of the total marks. Both exams will address the learning outcome 01, 02 and 03.
