<p>This module will enable students to gain a critical understanding of prevention within public health strategies to appraise epidemiology data, health needs assessment, service user engagement and partnership working, realistic evaluation and related policy in relation to a specific public health issue and specific communities.</p>

<p>Application of public health theories and concepts;            application of public health prevention strategies &amp; debating the evidence surrounding prevention;            specific protection, prevention and screening successes and challenges;            national and local policy focus on prevention with case study: immunisation and the need for policy reforms;            Public Health England setting the agenda;            health needs assessment, community profiling, sources of data including indices of deprivation;            prioritising health needs; engaging communities, service user and carer involvement and partnership working;            realistic evaluation of prevention strategies &amp; future prevention priorities.</p>

2	Critically discuss the contribution of key stakeholders in communities, multi-agency working, and policy focused on prevention strategies in public health.
3	Apply community and public health knowledge to develop community health profiles for specific community and public health issues.
4	Evaluate public health epidemiological data, community profiles, community health needs assessment, public health strategies and evaluations.
5	Manage a coherent and cogent report developing critical report writing skills.

Learning, Teaching and Assessment Strategy
<p>This module will be delivered using research informed teaching with Interactive technology enhanced learning and directed study.</p> <p>Lectures using the VLE with weblinks, podcasts and embedded twitter feeds will complement learning alongside seminars, group work with service users and carer involvement and individual tutorials. This strategy will enhance students experiences of current issues, their ability to link theory to public health prevention strategies and explore how to tackle specific public health issues in specific communities (LO 1,2,3,4).</p> <p>A series of practical sessions on report writing are designed to enhance students report writing skills (LO 5). Students will work individually to research, embed their understanding and report on epidemiological data, demonstrating an understanding of trends and projections, community profiles, health needs assessment, evaluation findings, and how this can be related to public health strategies (LO 1,2,3,4,5).</p> <p>Students have optionality in negotiating their chosen public health issue and specific geographical community to develop a community public health profile (LO 3).</p> <p>Public Health Report: Prevention in Action will assess LOs 1-5. Each student will write a 3,000 word report drawing upon a report brief of key questions for their chosen public health topic within a specific community.</p> <p>Students will be given formative feedback from their report plans during tutorials.</p>
