### **Terms of Reference and Composition 2024/25**

#### **Terms of reference**

1. The Senate is the supreme academic authority of the University responsible for overseeing academic quality and standards, and shall, subject to the powers reserved to the Council by the Statutes, take such measures and act in such a manner as shall appear to it best calculated to promote the academic work of the University both in teaching and research and shall regulate and superintend the education of the students of the University.
2. Senate has powers defined in the University Statutes article 12(1) – 12 (5) (see appendix 1)

#### **Frequency of meetings**

The Committee should meet no less than four times per academic year.

## Quorum

A quorum comprises at least 50% of the members of the Committee (including vacant posts), including the Chair or the Chair's nominee. This shall be rounded up to the nearest whole number. In the absence of a quorum, no formal resolution may be passed, but informal recommendations for decisions may be made to be considered and ratified at a subsequent meeting.
